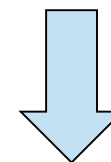
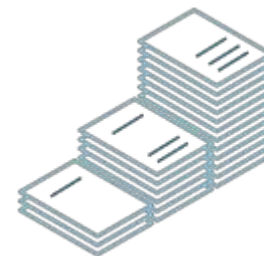

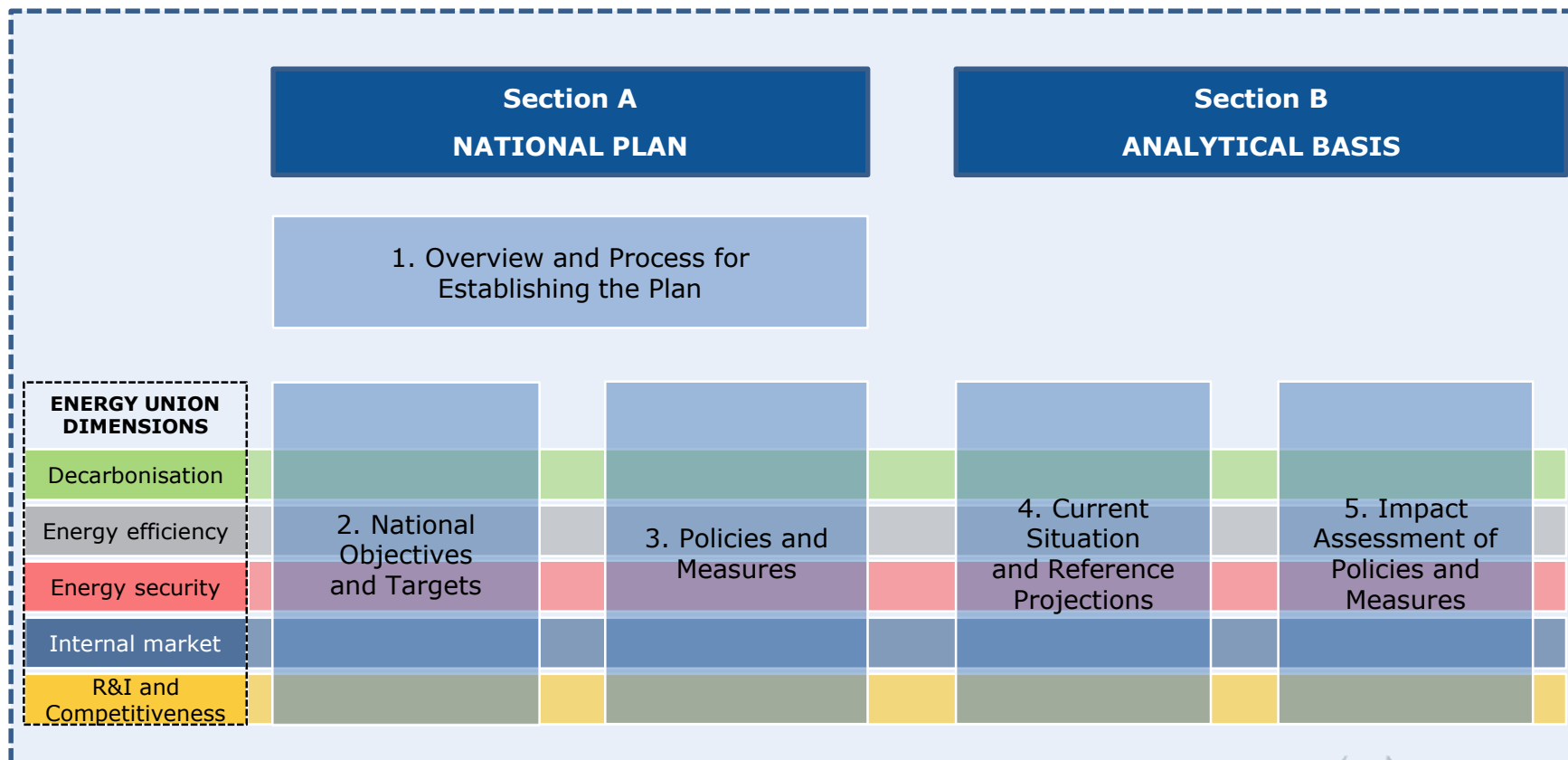

NECP - BINDING TEMPLATE AND 10 YEAR PLANNING CYCLE

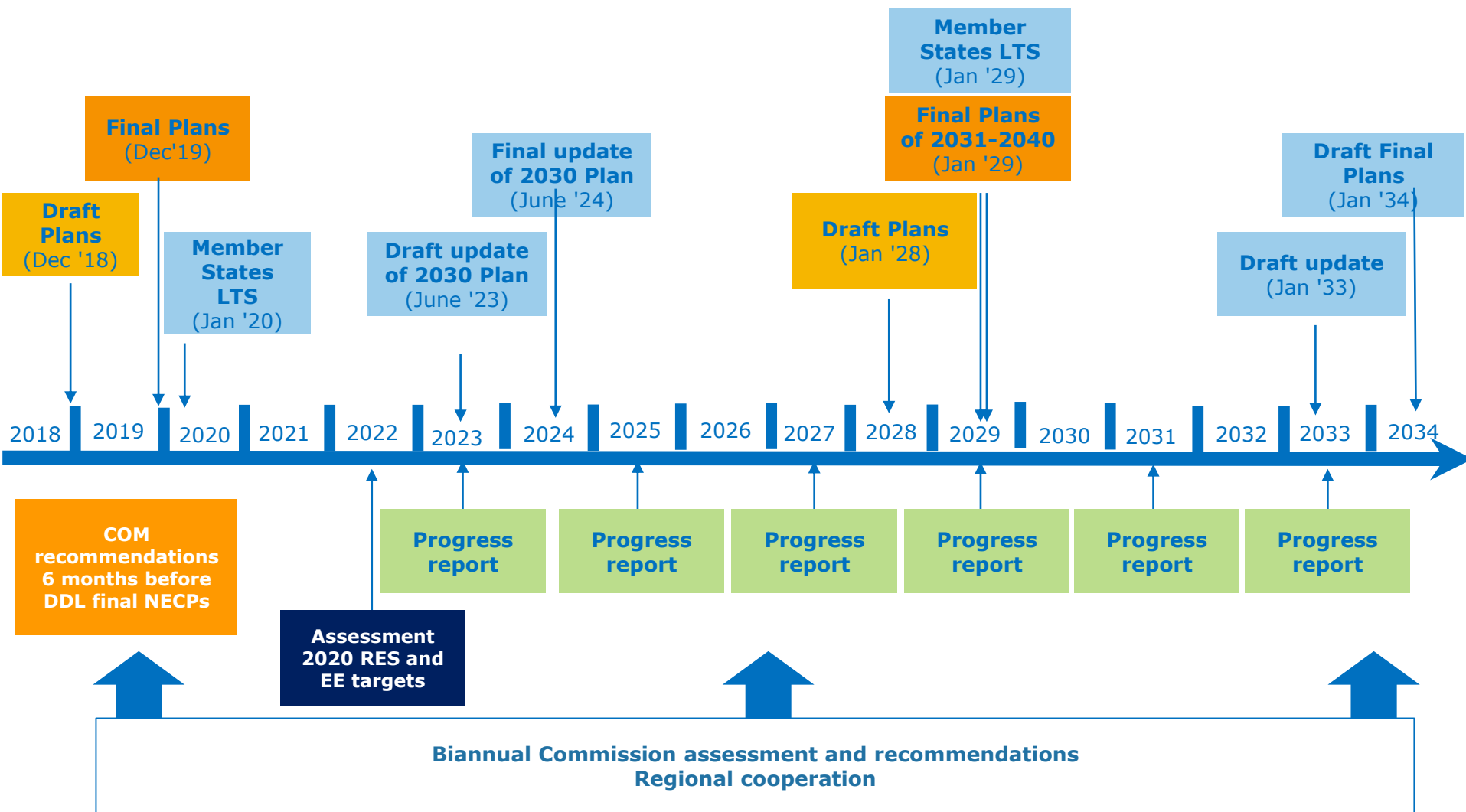


3. PUBLIC CONSULTATION AND MACRO-REGIONAL COOPERATION



- Public to be given **early and effective opportunities to participate in the preparation of the NECP** as well as the Long Term Strategy.
- Multilevel climate and energy dialogue: **local authorities**, civil society, business, investors and other relevant stakeholders.
- MS to identify opportunities for regional cooperation and consult neighbouring Member States.
- MS shall consult neighbouring countries. MS can consult third countries that have expressed an interest.

4. STATE OF PLAY

- All 28 draft plans submitted to the Commission.
- Assessment is on-going.

5. MFF and NECPs

- **25% mainstreaming** target in the next MFF proposed by the Commission (20% today).
- Common Provision Regulation proposal:
 - **Regional and local authorities shall be involved** in the preparation of Partnership Agreements.
 - The Commission will take into account relevant **country specific recommendations** in its assessment of Partnership Agreements.
 - **Fulfilment of enabling conditions is required** for ERDF and Cohesion Fund, including:
"NECPs are adopted and include i) all elements required by the template of the Governance Regulation and ii) an indicative outline of envisaged financing resources and mechanisms for measures promoting low-carbon energy".
